No. A/1/2016- MOBC (NSP): In continuation of this Directorate's Notification of even number dated 20/08/2016, it is hereby reminded to all concerned that the last date for submission of online applications under Minority Pre-Matric and Minority Post-Matric (Class XI & XII) scholarships for the year, 2016-17 under the National Scholarship Portal (NSP 2.0) is fast approaching (30th September, 2016). Up-to date status of online applications falls short of the target allocations made by the Ministry by a big margin. It is, therefore, requested to expedite submission of online applications to avoid last hour rush complications like systems failure due to excessive load, connectivity problems, etc.

2. Important points for applying Minority Scholarships, 2016-17 online under NSP 2.0:

- Website for filling up of Online Application is www.scholarships.gov.in. A link to this site is also available in the website of the Ministry i.e. www.minorityaffairs.gov.in
- Aadhaar Number is mandatory from the Academic Session 2016-2017 onwards; Aadhaar enrolment number/receipt number can be used for online application and this is to be updated with Aadhaar Number for DBT;
- Supporting documents for scholarships amount/total annual fees upto Rs. 50,000/- (Rupees Fifty thousand only) to be kept at institution level and for scholarships amount more than Rs. 50,000/- are to be uploaded on the NSP;
- Students' bank account number is to be seeded/linked with their Aadhaar Number;
- Print out of online application with supporting self-attested documents (except the Income Certificate which is to be original) are to be submitted to the respective institutions.
