MINUTES OF THE TENTH MEETING OF THE STATE LEVEL COMMITTEE OF THE PRIME MINISTER'S NEW 15<sup>TH</sup> POINT PROGRAMME FOR THE WELFARE OF MINORITIES INCLUDING MsDP FOR THE QUARTERS ENDED 31/12/2015 & 31/03/2016 HELD ON 10<sup>TH</sup> MAY, 2016 AT 11.00 A.M. AT THE CONFERENCE HALL OF THE MANIPUR SECRETARIAT, SOUTH BLOCK WITH SHRI. O. NABAKISHORE SINGH, IAS, CHIEF SECRETARY, GOVERNMENT OF MANIPUR IN THE CHAIR.

List of members present is at Annexure-I.

At the outset, Chief Secretary, Government of Manipur welcomed all the members and officers present in the meeting and requested the Secretary (MOBC), Government of Manipur to introduce the agenda of the meeting. Secretary (MOBC), Government of Manipur highlighted salient points/features of the PM's New 15-PP for the Welfare of Minorities and he asked the Director, MOBC, Manipur to make the power point presentation on the status of the implementation of the programmes.

2. Director (MOBC), Manipur has informed the members present that MsDP fund allocation (Central Share) during the 12<sup>th</sup> Plan has been revised in respect of 25 (twenty five) approved Minority Concentration Blocks (MCBs) to Rs. 12476.00 lakhs from the earlier allocation of Rs. 8317.00 lakhs indicating details of the District-wise financial progress as detailed below:

3. Director (MOBC), Manipur informed the members that proposals have been received from the Deputy Commissioners/Executive Directors, DRDAs of Imphal East, Thoubal, Chandel, Ukhrul, Senapati and Churachandpur Districts for inclusion of new projects/schemes under MsDP for the balance fund available. All the DCs/EDs furnished justification for the inclusion of new projects/schemes of their districts under MsDP.
4. Regarding the progress report of Prime Minister's 15 Point Programme, Director (MBC) informed that most of the line Department/Agencies have not submitted their targets and achievement status and hence proposed to review the progress report in the next SLC meeting.
5. It was informed by some of the Chairmen of Autonomous District Councils (ADCs) that they have been sidelined in the decision making process and implementation of the MsDP including functioning of the DRDA administration by the Deputy Commissioners. Concerned Deputy Commissioners explained the working of DRDAs and role of the ADC Chairmen.
6. After a thorough discussion the State Level Committee (SLC) took the following decisions:
  - i). The Committee decided to defer the review of Progress Reports of line Deptts/Agencies under Prime Minister's New 15 Point Programme for the Quarters ended 31/12/2015 and 31/03/2016 to the next SLC meeting due to incomplete submission of the required reports by all the concerned line deptts.
  - ii). With regard to the grievances of the Chairman, ADCs, the SLC decided that the concerned Deputy Commissioners of the Hill Districts should ensure participation of ADCs in the selection & monitoring of MsDP and other schemes as per the guidelines of the Central Ministry and the State Government.
  - iii). DC, Tamenglong district was advised to submit proposal for the balance fund allocation for implementation of MsDP in the district within a period of two weeks.
  - iv). The clarification submitted by DC, Imphal East for Jiribam CD Block on the earlier proposal (3 nos) under MsDP 12<sup>th</sup> Plan, stating that all the proposals are under gap filling projects under RMSA/NRHM, is to be forwarded to the Ministry for approval. (Annexures -VA)
  - v). The proposal submitted by the Deputy Commissioners of Ukhrul, Churachandpur, Chandel, Imphal East, Senapati, Thoubal Districts for taking up additional projects for the balance fund under MsDP during the 12<sup>th</sup> Plan in respect of MCBs/Clusters were approved as given in the Annexures indicated at para-vi subject to the following conditions:
    - a) Removal of proposals for i). Construction of Girl's Hostel at Urup High School, Urup and ii). Construction of 10 ACRs at Kiyamgei Heibong Makhong Jr. Hihg School, Kiyamgei under Imphal East-II CD Block of Imphal East District in the wake of legal notice served by Shri. B.P. Sahu, Advocate,
    - b) Inclusion of school/institute code for the proposed schools,
    - c) Non duplicity of schemes, standardized/approved rates of the proposed schemes from the concerned line departments.
