MINUTES OF STATE LEVEL COMMITTEE MEETING ON PRIME MINISTER'S 15 POINT PROGRAMME FOR THE WELFARE OF MINORITIES FOR MsDP HELD ON 20TH SEPTEMBER, 2012 AT 11:00 AM WITH SHRI D.S POONIA, CHIEF SECRETARY, GOVERNMENT OF MANIPUR IN THE CHAIR.

The Chief Secretary, Manipur welcomed all the members and officers present in the meeting. He requested the Director (MOBC & SC), Government of Manipur to introduce the agenda.

2. Director (MOBC & SC) placed the agenda which focused on fresh proposals for MsDP submitted by the districts. Director/MOBC & SC informed that only Thoubal and Chandel Districts have submitted fresh proposals. He also informed that the Ministry of Minority Affairs has informed that MsDP shall continue and has requested the Government of Manipur to submit proposal within Rs. 100.00 crores (approx) subject to refund of VAT (Rs. 3.43 crores) and submission of UC of the last year's released funds (Rs. 26.65 crores).

3. Director (MOBC & SC), Manipur also stated that the District Planning Committee will have to prepare and furnish the fresh proposals for all MsDP schemes. He clarified that the earlier Cabinet decision devolving powers to the District Councils/Zilla Parishads was only for implementation part since it was then a "one time" sanctioned scheme. Now, that it has been extended vide Ministry's letter No.3/32/2012-PP dated 03-08-2012 it may be necessary to apprise and seek policy decision of the cabinet on devolution to the ADCs in the five Hill Districts and the ZP in Thoubal MCD in the valley.

4. After discussion, the Committee decided that -

- i) the MOBC & SC Department shall immediately move the State Cabinet for devolution of powers to the ADCs/ZP (Thoubal) to formulate the MsDP schemes as per the Ministry's guidelines.
- ii) the MOBC & SC shall mandatorily involve Manipur State Minorities Commission in the selection of MsDP schemes and the beneficiaries through the ADCs in the Hill Districts and ZP, Thoubal.

The meeting ended with a vote of thanks.
