Sir,

I am directed to convey the sanction of the President for release of Rs.1,40,00,000/- (Rupees one crore forty lakhs only) to the Government of Manipur towards Central Share for construction of 02 OBC Boys & Girls hostels to accommodate 100 inmates in each hostel under the Centrally Sponsored Scheme of Hostels for OBC Boys & Girls during 2010-11 as per annexure. The State Government has submitted a an estimated cost of construction of the hostel of Rs.374.42 lakhs, out of which the Central Share will be Rs.140.00 lakhs and the balance of the cost amounting to Rs.234.42 lakh will be borne by the State Government.

2. This sanction relates to Plan Expenditure and is in accordance with the pattern of assistance prescribed by the Planning Commission.

3. The expenditure is debitable to the Major Head/Grant Sub-Head etc. as indicated below: -

4. The scheme of Hostels for OBCs has been revised in 2010-11, a copy of which has already been sent to the State Govt. vide this Ministry's letter No. 11015/1/2007-BC-1(Vol.II) dated 10.12.2010. It is, therefore, requested that while constructing the new hostels, the physical norms and other parameters envisaged in the revised scheme may be taken into account by the State Government.

5. It may also be ensured that the construction work of the hostels is completed within a period of one year from the date of the sanction of the grant. A completion report along with photographs and Operationalization of the Hostel Buildings completed may be furnished by the State Government their next proposal.


6. The audited Utilization certificate and Statement in respects of the funds released during the previous years shall be submitted for considering release of any Grant-in-aid to the State in next financial year. The UC should be submitted within 12 months of the closure of the financial year by the State Govt. of Gujarat. In the case of non-utilization of the central funds released for the purpose for which it is released, the State Govt. shall be liable to refund the funds to the Ministry with interest at 10% per annum for the period the funds retained by the State Govt. unutilized.

7. The State Government is also requested that the physical quarterly progress report on construction of work along with photographs and financial performance may please be furnished to the Government of India regularly. The Project sanction is subject to all the conditions stipulated in the Scheme.

8. It is requested that arrangement may kindly be made to credit this amount to the State Government of Manipur in accordance with the procedure laid down in the Ministry of Finance OM No.2 (45)/76-Spl. Cell, dated 30-08-1976 under intimation to this Ministry.

9. This sanction is being issued with the concurrence of Integrated Finance Division of this Ministry vide their Dy.No.541/JS&FA(SJ&E)/11, dated 25.02.2011.


